MINUTES

9:00 a.m. -10:30 a.m November 13th, 2015 Jakarta Convention Center, Jakarta, Indonesia

AGENDA ITEM 1. ROLL CALL

Mrs. Liu Beijian, the Secretary General stated that there were 80 IWUF member federations present, which met the quorum required for the Congress.

AGENDA ITEM 2. ADDRESS BY PRESIDENT YU ZAIQING

President Yu firstly welcomed all those present at the 13th IWUF Congress and expressed his appreciation to the Indonesian Wushu Association (IWA) for their warm hospitality and great effort in organizing the 13th World Wushu Championships and IWUF's various meetings.

President Yu reported that the IWUF had made great achievements over the last two years. He covered the following main issues:

1) 2020 Olympic bid

Wushu was shortlisted as Additional Event for the Tokyo 2020 Olympic Games in 2015. He said that irrespective of the fact that wushu did not make the final list, the selection indicates the recognition and acceptance that wushu is of great Olympic potential and a result of all

IWUF members' collective efforts. President Yu remained optimistic on wushu's Olympic chances.

2) Wushu's inclusion into multi-sports games

Wushu was successfully included into the 2017 Taipei Summer Universiade. The IWUF signed a collaboration agreement with FISU in April 2015. Wushu is also included in the program of the university championships in 2018. President Yu thanked the Chinese Taipei Wushu Federation for their support in this effort.

President Yu also said that wushu has again been included into the Baku 2017 Islamic Solidarity Games through the efforts of the Azerbaijan Wushu Federation and the Iranian Wushu Federation.

3) Success of past events and competitions

President Yu stated that the Nanjing 2014 Youth Wushu Tournament was held in conjunction with the Nanjing 2014 Youth Olympic Games. At his invitation, both IOC President Thomas Bach and Honorary President Dr. Jacque Rogge watched the wushu competition and awarded medals to the winners. The presence of the dignitaries attracted tremendous media attention and provided excellent exposure for the promotion of wushu.

Taking part in the IOC Nanjing Sports Lab program also added to the IWUF's positive Olympic relationship, and brought wushu up close to many IOC members, including President Bach. During the YOG in Nanjing, President Yu also arranged Taijiquan classes for Dr. and Mrs. Jacque Rogge who enjoyed the lessons immensely.

President Yu stated that the 5th World Junior Wushu Championships (Antalya, Turkey), 6th World Traditional Wushu Championships (Chizhou, China), 7th Sanda World Cup (Jakarta, Indonesia) and the 1st World Taijiquan Championships (Chengdu, China) were held successfully in 2014. He said that the first edition of World Taijiquan Championships has set a milestone for the further globalization of Tajiquan, an important style of wushu.

4) Financial situation

President Yu stated that IWUF has enjoyed a financially sound operation for its two offices.

The funding and sponsorships have been secured which enable the functioning of the headquarters in Lausanne and the well-staffed office in Beijing, as well as IWUF's events and activities throughout the year.

The funding also enables the newly established solidarity program that supports the IWUF's member federations with equipment donations, technical training and participation in our official events. The solidarity program will expand and support more of our members who are in need of help financially, technically and administratively.

5) Good governance and improved communication

President Yu stated that the Lausanne headquarters has been granted a tax-exempt status by the local authority. The operation of the headquarters is going smoothly and provides us an outreach to interact with the IOC and relevant international sports organizations.

An excellent management team in the IWUF Secretariat headed by Executive Vice President Anthony Goh and Secretary General Liu Beijian has been established, with extraordinary achievements in the last four years. The management has improved event and tournament operations tremendously and successfully expanded the media and social outreach which creates a lively and interacted wushu global community today.

An official online video platform, World Wushu TV, has been launched in early November which will stream the 13th World Wushu Championships live into the homes and offices of people worldwide. After these world championships, the platform will continue to be used for spreading technical and teaching material to our global wushu family.

President Yu closed his address by saying that wushu and IWUF still need improvements within various areas. To take progress to new heights, the IWUF needs to improve its competition format, expand into main stream media, create commercial events, develop and nurture more professional personnel, in both technical and administrative areas to assist under-developed members and to accelerate its globalization efforts.

AGENDA ITEM 3. WELCOME ADDRESS BY THE PRESIDENT OF THE INDONESIA WUSHU ASSOCIATION

Mr. Supandi Kusuma, the President of the Indonesia Wushu Association (IWA) welcomed all the participants to the 13th World Wushu Championships and to Indonesia. He expressed his appreciation to the IWUF and the member federations of IWUF for their support and trust placed in the Organizing Committee of the 13th WWC. The IWA will fulfill its commitment and spare no efforts in organising a high-quality championships.

AGENDA ITME 4. APPROVAL OF THE AGENDA

President Yu asked if there were any votes against the adoption of the agenda, or any abstentions.

Summary of voting results: Votes for: 80. Votes against: 0. Abstention: 0.

Decision: The Congress unanimously adopted the agenda of the 13th IWUF Congress.

AGENDA ITEM 5. APPROVAL OF THE MINUTES OF THE 12TH IWUF CONGRESS

President Yu asked if there were any votes against the approval of the minutes of the 12th IWUF Congress, or any abstentions.

Summary of voting results: Votes for: 80. Votes against: 0. Abstention: 0. Decision: The Congress unanimously approved the minutes of the previous Congress.

AGENDA ITEM 6. WORK REPORT (2013-2015) BY SECRETARY GENERAL

Mrs. Liu Beijian, the Secretary General reported on the work since the 12th Congress which was held in Malaysia in 2013. This includes the following topics:

1) Competitions and Events

1.1 5th World Junior Wushu Championships

The 5th World Junior Wushu Championships was held from March 11 to 18, 2014 in Antalya, Turkey. A total of 513 participants aged from 16 to 18 from 43 nations/regions participated in this championships. This event also served as a qualifier for the Nanjing 2014 Youth Wushu Tournament which was held in last August. The championships were a great success mainly due to the great efforts invested by the Turkish Wushu Federation.

1.2 Nanjing 2014 Youth Wushu Tournament (22-24 August 2014, Nanjing, China)

Approved by the IOC, the "Nanjing 2014 Youth Wushu Tournament" was held from August 22 to 24, 2014 in Nanjing, China. A total of 100 junior athletes from 35 countries/regions participated in the event. President Yu Zaiqing and many high ranking officials from the local governments attended the opening ceremony. The IOC President Mr. Thomas Bach, IOC Honorary President Mr. Jacques Rogge, as well as four IOC members were invited by President Yu as spectators at the competition and awarded medals. The attendees of the IOC dignitaries spoke highly of the event and their presences generated excellent media coverage for wushu.

The IWUF held two press conferences during the Nanjing 2014 Youth Olympic Games.

1.3 Nanjing 2014 Sports Lab Wushu Showcase (17-27 August 2014, Nanjing, China)

Staged by the IOC, the "Nanjing 2014 Sports Lab" was held in conjunction with the Nanjing 2014 Youth Olympic Games (YOG) as an educational and cultural event. Wushu was one of the four sports showcased at the Sports Lab. A delegation of 27 persons including 16 top

international athletes from our member federations participated in this event. It was a fabulous opportunity to present wushu in an Olympic environment. During these 11 days, the wushu showcase drew attention from numerous IOC members, NOC officials and YOG athletes as well as local participants. The highlight of the event was when the IOC President Thomas Bach paid a visit to wushu venue and tried out wushu. His action photo with our athletes was widely published in the relevant IOC and other media.

1.4 6th World Traditional Wushu Championships (26-29 October 2014, Chizhou, China)

A total of 2000 participants from 46 countries/regions participated in the event. It is the first time that traditional wushu championships was held outside of a gymnasium was a unique experience for all participants. The participants had the opportunity to enjoy the magnificent view of the natural beauty of Mount Jiuhua, one of the sacred mountains of Chinese Buddism. However, there were a few problems with the efficiency and quality of the execution of the event. The Secretariat sent out a survey to the participating teams following the conclusion of the event and many of them responded with good suggestions, which will be used to improve the planning and organization of future world traditional wushu championships.

Mrs. Liu stated that it was suggested by the Traditional Wushu Committee and approved by the Executive Board that the future world traditional wushu championships will be held in the odd years instead of even years, namely the next world traditional championships will be held in year 2017, for the reason that there are many world events such as the World Junior Championships, Sanda World Cup, World Taijiquan Championships in the even years.

1.5 1st World Taijiquan Championships (1-4 November 2014, Chengdu, China)

A total of 297 participants from 31 countries/regions took part in the event. The event applied the newly formulated taijiquan rules and scoring method for the first time. The venue was packed to maximum capacity by eager spectators on a daily basis who were wowed by the grace, athleticism and beauty of taijiquan practitioners from around the world. The new format of competition was well received by participating teams.

1.6 7th Sanda World Cup (20-21 November 2014, Jakarta, Indonesia)

A total of 53 athletes representing 18 countries/regions vied for top honors in their respective

weight divisions to be crowned the champion of champions. The biennial event featured the top 3 placed fighters from the 12th World Wushu Championships. This marked the first time that the Sanda World Cup was held outside of China, and the Indonesian Wushu Association worked tirelessly to ensure this event was a resounding success.

2) 2014 International Wushu Judges Examination Course

2.1 International Wushu Judges Examination Course (June 1 - 7, 2014 Catania, Italy)

A total of 73 participants from 15 countries/regions attended the course. The participants learned the 3rd Set of International Wushu Taolu Routine, all together 10 routines and they all passed the examination.

2.2 International Wushu Judges Examination Course (August 25 - 31,2014 Shanghai, China)

A total of 135 participants from 35 countries/regions took part in the course. Among them, 129 judges passed the examination and were conferred the international judges certificates. In the 6-day course, the participants learned the International Competition Rules, Judging rules and methods, the 3rd Set of International Compulsory Competition Routines, and participated in taolu and sanda technical training. Prof. Xu Weijun who is a well respected expert in the field conducted the training.

2.3 International Taijiquan Judges Examination Course (October 24 - 30, 2014 Chengdu, China)

A total of 25 judges from 17 countries/regions participated in the course. The course was specifically compiled for the judges of the 1st World Taijiquan Championships which is a new competition system launched by the IWUF to further promote Taijiquan at a higher level. The International Taijiquan Competition Regulations includes various high levels of difficulty movements and new rules. The participants who passed the exam judged at the 1st World Taijiquan Championships.

3) International Coaches Training Course

3.1 International Wushu Coaches Training Course (March 18 - 21, 2014 Antalya, Turkey)

A total of 114 judges, coaches and athletes from 28 countries/ regions participated in the course. Within one week, the participants learned the 3rd Set International Wushu Competition Routines. Participants also attended theoretical studies, and learned how to create optional routines, how to formulate a training program, how to guide athletes before competitions and how to fill out the forms for degree of difficulty.

3.2 The following coaches and athletes courses were held in 2015:

3.2.1 International Wushu Coaches Training Course (March 1 – 10, 2015 Hamamet, Tunisia).
68 participants from 7 countries participated in the course.

3.2.2 International Traditional Wushu Coaches Training Course (March 24 - 31, 2015 Guangzhou, China). 60 participants from 11 countries/regions participated.

3.3.3 International Wushu Coaches Training Course (May 15 - 21, 2015 Pachuca City, Mexico). 38 participants from 4 countries participated.

3.3.4 International Wushu Coaches Training Course (May 31 - June 7, 2015 Turin, Italy). 44 participants from 7 countries/regions participated.

3.3.5 International Taijiquan Athletes Training Course (May 31 - June 7, 2015 Turin, Italy).15 participants from 3 countries/regions participated.

3.3.6 International Traditional Wushu Coaches Training Course (June 8 - 14, 2015 Warsaw, Poland). 44 participants from 7 countries/regions participated.

Ms. Liu stated that it was proposed by the Technical Committee and approved by EB that all the judges at the 13th world Wushu Championships will first need to attend the refresher courses here and take an examination. Those who do not meet the requirement are not permitted to judge at this competition.

Another change would be adopted during the 13th WWC that all Taolu judges overall performance scores (B Group) will be openly displayed to the public and an open display

scoring will be implemented in sanda competition for all the sideline judges.

4) Anti-doping Progress

The IWUF's current anti-doping program is in full compliance with the World Anti-Doping Code. The Registered Testing Pool (RTP) is composed of 10 to 15 athletes, which is a reasonable size due to the IWUF's scale at this stage. To further develop the Anti-Doping management, it is suggested that the number of RTP athletes to be increased in the near future. During the 5th World Junior Wushu Championships, an anti-doping outreach was successfully conducted in which junior athletes were invited to do a prize-awarded quiz. As required by WADA, the IWUF has applied its new Anti-Doping Rules in 2015 which is in line with the current World Anti-Doping Code.

5) Broadcasting production, live streaming and OTT platform

The IWUF's brand new TV channel will stream the entire 13th World Championships live, allowing viewers all over the world with an internet connection to watch the competition in real time and not miss a minute of wushu action. The event will be filmed in full HD quality and professional broadcast will offer expert commentary, in addition to interviews with athletes and wushu personalities.

The IWUF engaged the services of premier company IEC in Sports to produce and stream live the 13th World Wushu Championships from Jakarta. The IEC in Sports, a Lagardère Unlimited company, has worked with various international sport federations. The OTT (Over the top) platform offers the IWUF the opportunity to engage with fans through a single destination for high quality produced live and VOD content and a social community to share ideas and content.

Mrs. Liu concluded her report.

At the end of the report, Mr. Miguel Angel Pastor Calderon, the President of the Peruvian Wushu Kungfu Federation expressed his gratitude to the IWUF in the development of wushu worldwide which was witnessed by all members, and requested support from IWUF regarding wushu movement in Peru and wushu's inclusion into the 2019 Pan American Games.

President Yu said that he met with the President of the Peruvian Olympic Committee in the ANOC meeting in 2015 and received his positive response regarding the support for this issue. The IWUF will work closely with the Peruvian Wushu Federation about this.

AGENDA ITEM 7. APPROVAL OF THE SPONSORS AND DONATIONS

President Yu said that as he pledged during his last election in the 11th Congress in 2011, he had make further efforts to secure funding for the promotion of wushu movement. Through his continued efforts, the Chinese Olympic Committee promised to provide a donation without conditions, with an amount of not less than USD 1,000,000 annually. The Executive Board will have the right to make decisions as to how to utilize the money.

President Yu asked if there were any votes against the adoption of the donation from Chinese Olympic Committee, or any abstentions.

Summary of voting results: Votes for: 80. Votes against: 0. Abstention: 0.

Decision: The Congress unanimously approved the donation by the Chinese Olympic Committee.

AGENDA ITEM 8. FINANCIAL REPORT (2013-2015) BY TREASURER

(Auditor's Reports of 2013 & 2014 were attached)

Mr. Urs Krebs, the Treasurer, referred to the financial reports of 2013 and 2014. He reported that the main income is from sponsors with an amount of about CHF 205,457.30 in 2013 and CHF 944,483.63 in 2014, respectively. A donation from the Chinese Olympic Committee

was seen in the assets with an amount of CHF 1,714,979.88 in 2014. He noted a decrease in the income from membership fee in 2014 compared with 2013, and looked forward to more members to perform their duty to make this payment.

The biggest expense over the past two years was the staff salaries and office rental. Another significant increase in expense was for promotion and sport development, such as the Sports Lab Wushu Demonstration at the Nanjing 2014 Youth Olympic Games and development of public relations. The total costs were CHF 232,165.11 in 2013 and CHF 982,917.69 in 2014, respectively.

With the acceptance of the donation of the Chinese Olympic Committee by the Congress, the IWUF is in a stable financial situation. This income will significantly finance most of IWUF's future activities and projects such as Solidarity Program, media expansion project (like the newly launched "Wushu TV"), and public relations.

A budget process will be established for the next period to better define and evaluate the financial status.

At the end of the report, Mr. Paulo Araujo of Portugal congratulated Mr. Urs Krebs on the report.

Decision: The Congress unanimously approved the financial report.

AGENDA ITEM 9. IWUF NEW MEMBERSHIPS

Ms. Liu Beijian stated that it was the recommendation of the Executive Board that the Rwanda Wushu Federation could be accepted as the full member of IWUF after reviewing their application.

President Yu asked if there were any votes against the acceptance of full membership of Rwanda Wushu Federation, or any abstentions.

Summary of voting results: Votes for: 80. Votes against: 0. Abstention: 0.

Decision: The Congress unanimously agreed to accept the Rwanda Wushu Federation as IWUF full member.

AGENDA ITEM 10. APPROVAL OF THE AMENDMENT TO THE CONSTITUTION

Mr. Anthony Goh, the Executive Vice President introduced the proposed amendment to the IWUF Constitution made by members and the lawyer engaged in Lausanne. He noted that the changes had been made for administrative and structural improvement. These changes include:

- 1) Change to add the 'Preamble' section, in order to better define the term of wushu.
- 2) Changes to membership status.
- 3) Changes to the composition of the Executive Board, with duties of the members, and conditions of continental federations to nominate the Executive Board members, etc.
- 4) Changes to refine language in certain provisions.

President Yu asked if there were any votes against the approval of the proposed amendments to the Constitution, or any abstentions.

Summary of voting results: Votes for: 78. Votes against: 2 (Turkey, Italy). Abstention: 0.

Decision: The Congress approved the proposed amendments to the Constitution.

AGENDA ITEM 11. ELECTION OF IWUF LEADSHIP FOR 2015 – 2019

Mrs. Liu conveyed the message from Mr. Raymond Smith, the Vice President of IWUF, who was absent from the 13th Congress. It was announced in his letter that he would step down from the current position of IWUF Vice President which he served for 25 years. President Yu said that Mr. Smith had worked for wushu for over 30 years and made great contribution to the European and international development of wushu and he deserved a huge applause.

General Giuseppe Facolni, the honorary member of the Executive Board addressed the Congress. He thanked President Yu, Mr. Anthony Goh, and Mr. Supandi Kusuma for their diligence and hospitality, and expressed his hope of wushu to gain access into the 2024 Olympic Games.

Mr. Glen Keith, the Vice President and Presidential Candidate made a speech to the Congress regarding his withdrawal of nomination of candidacy for IWUF President, and extended his congratulations to the incumbent President Mr. Yu Zaiqing on yet another new term. Mr. Keith also announced that he decided to step down from his current positions of Vice President of IWUF and the President of Oceania Wushu Federation effective from the end of the 13th WWC. He said he will continue his commitment and support to the IWUF and President Yu. He finally thanked Mr. Anthony Goh for his friendship, deep dedication and commitment to wushu of many years.

Mr. Anthony Goh introduced the details pertaining to the newly added article to the constitution, that each host of the World Wushu Championships will be added as a member of the Executive Board for a 4-year term. Being the host of the 13th WWC, the President of the Indonesia Wushu Association will serve for the term of 2015-2019. Each host of the WWC will serve for a 4-year term provided that there is not another EB member from the same nation/territory. Amongst others, one of the benefits of this is that the experience gained from hosting the World Wushu Championships may be shared and retained.

Voting Results:

1) The Congress unanimously reelected Mr. Yu Zaiqing as the IWUF President for the

tenure of 2015-2019.

Summary of voting results: Votes for: 80. Votes against: 0. Abstention: 0.

- President Yu Zaiqing nominated Ms. Liu Beijian as the Secretary General, and Mr. Urs Krebs as the Treasurer.
- 3) The Congress approved the nomination of Executive Board members for the tenure of 2015-2019.

AGENDA ITEM 12. DATE AND PLACE OF THE 14TH WORLD WUSHU CHAMPIONSHIPS & IWUF CONGRESS

President Yu stated that it was the recommendation of the Executive Board to award the right to host the 14th World Wushu Championships (14th WWC) to the city of Kazan, Russia. He asked if there were any votes against the recommendation, or any abstentions.

Summary of voting results: Votes for: 80. Votes against: 0. Abstention: 0.

Later Mr. Gleb Muzrukov, the President of the Russian Wushu Federation made a presentation to the Congress on the Kazan's bid to host the 14th WWC.

Decision: The Congress unanimously approved that the 14th WWC and Congress will be held in Kazan, Russia in 2017.

AGENDA ITEM 13. DATES AND PLACES OF THE IWUF COMPETITIONS IN 2016

Mr. Goh introduced that the Executive Board had made a decision that the Bulgaria Wushu Federation was awarded the right to organize the 6th World Junior Wushu Championships.

Mr. Goh said that the Polish Wushu Federation made a bid for the 2nd World Taijiquan

Championships during the 31st IWUF Executive Board Meeting. The Executive Board decided that the Polish Wushu Federation will be awarded the right to host the event should they obtain confirmation of financial support from their government within 30 days from the meeting.

He continued to say that the bid for the 8th Sanda World Cup is still open. The 7th Traditional Wushu Championships will be held in 2017. The hosts will be decided by the Executive Board soon.

AGENDA ITEM 14. MISCELLANEOUS
