THE 9TH WORLD JUNIOR WUSHU CHAMPIONSHIPS

REGULATIONS

The 9th World Junior Wushu Championships (9th WJWC) is the official world championship event which is hosted by the International Wushu Federation. The World Junior Wushu Championships takes place biennially and is the official pinnacle junior championships of the IWUF and features its highest competitive level amongst its junior athletes. The Wushu Federation of Brunei is responsible for the organization of the 9th WJWC under the auspices of the IWUF.

A. DATE AND PLACE

The 9th WJWC will be held from September 22 – 30, 2024 in Bandar Seri Begawan, Brunei Darussalam.

B. VENUES

1. TAOLU

C. COMPETITION EVENTS

1. TAOLU

Group A: 3rd Set of International Competition Routine: Changquan, Daoshu, Jianshu, Qiangshu, Gunshu, Nanquan, Nandao, Nangun, Taijiquan, Taijijian, Taijishan; Duilian

Group B: 1st Set of International Competition Routine: Changquan, Daoshu, Jianshu, Qiangshu, Gunshu; Nanquan, Nandao, Nangun; 42 Forms Taijiquan, 42 Forms Taijijian

Group C: Elementary Routine: Changquan (No.3 Elementary Routine), Daoshu, Jianshu, Qiangshu, Gunshu; Nanquan, Nandao, Nangun; Taijiquan (24 Forms), Taijijian (32 Forms).

2. SANDA

Junior Category:

Male: 48kg, 52kg, 56kg, 60kg, 65kg, 70kg, 75kg and 80kg

Female: 48kg, 52kg, 56kg and 60kg

Children's Category:

Male: 42kg, 45kg, 48kg, 52kg, 56kg

D. QUALIFICATIONS

1. Membership

- Only those member federations/associations which have paid their IWUF annual membership fees for 2022/2023/2024 will be permitted to participate in the Championships.
- The federation/ association applying to join IWUF may be invited to take part in the Championships after their applications have been accepted by the IWUF.

2. The Eligibility of the Athlete

- All Athletes must be citizenship of the country/region which they are representing.
- Those Athletes who have dual citizenship can only represent one (1) country/region in the championships.

E. PARTICIPATION METHODS

TAOLU:

1. Each country or region may enter one (1) team.
2. Each Taolu team shall be composed of a maximum of twenty-two (22) members including: one (1) team leader, two (2) coaches and one (1) doctor, four (4) observers and the following competitors:
 - **Group A:** 6 competitors (3 boys and 3 girls, who were born between January 1, 2006 – December 31, 2009)
Each Taolu competitor of Group A may enter at most 4 competition events (1 bare-handed routine, 1 short weapon routine, 1 long weapon routine and 1 dual event)
 - **Group B:** 4 competitors (2 boys and 2 girls, who were born between January 1, 2010 – December 31, 2012)
Each Taolu competitor of **Group B** may at most enter 3 competition events (1 bare-handed routine, 1 short weapon routine, and 1 long weapon routine)
 - **Group C:** 4 competitors (2 boys and 2 girls, who were born between January 1, 2013 – December 31, 2016)
Each Taolu competitor of **Group C** may at most enter 2 competition events (1 bare-handed routine, 1 weapon routine: either 1 short weapon or 1 long weapon)
3. Each competitor should bring along with them a valid Health Certificate (including electrocardiogram, pulse and blood pressure) issued within 30 days prior to the start of the competition signed by a qualified doctor and a Life Accidental Injury Insurance Certificate. All competitors are required to submit a completed and signed waiver of liabilities form, which has been signed by the competitor's parent or legal guardian.

SANDA:

1. Each country or region may enter one (1) team.
2. Each Sanda team shall be composed of a maximum nineteen (19) members including: one (1) team leader, two (2) coaches, one (1) doctor, four observers (4) and eleven (11) competitors (8 boys and 3 girls) separated as follows:
 - Junior Sanda Athletes

A maximum of five (5) boys and three (3) girls who were born between January 1, 2007 – December 31, 2009.

- Children's Sanda Athletes

A maximum of three (3) boys who were born between January 1, 2010 – December 31, 2012.

3. Each team may at most enter one (1) athlete per weight category, and each athlete may enter only one (1) weight category.
4. Each competitor should bring along with them a valid Health Certificate (including electroencephalogram, electrocardiogram, pulse and blood pressure) issued within 30 days prior to the start of the competition signed by a qualified doctor and a Life Accidental Injury Insurance Certificate. All competitors are required to submit a completed and signed waiver of liabilities form, which has been signed by the competitor's parent or legal guardian.

F. COMPETITION METHODS

The Rules and Methods may be interpreted solely at the discretion of the IWUF. In case of any disagreement in the interpretation of the rules, the Chinese version shall prevail.

1. TAOLU:

- Unless otherwise stated within these regulations, the competition will be conducted in accordance with the latest edition of the "IWUF Rules for International Wushu Taolu Competition and Additional Trial 2019" and utilize the Non-Degree of Difficulty Scoring Method (comprising of A Group – Quality of Movements Scoring & B Group – Overall Performance Scoring only).
- Time limit:
 - Changquan, Jianshu, Daoshu, Qiangshu, Gunshu, Nanquan, Nandao and Nangun Routine: no less than one (1) minute and ten (10) seconds (1min 10s).
 - Taijiquan, Taijijian and Taijishan Routine: 3 - 4 minutes.
 - Taijiquan (42 movements) Routine: 5 - 6 minutes.
 - Duilian Routine: no less than 40 seconds.
 - There is no time requirement for Elementary Routine.

2. SANDA:

- Unless otherwise stated within these regulations, the competition will be conducted in accordance with the "IWUF Wushu Sanda Competition Rules & Judging Method (2017)".
- The single knockout system will be adopted. If the number of competitors in a weight category is 3, a single round – robin method will be adopted. If only two or one athlete(s) registered in a weight category, the weight category will be cancelled.
- Following arrival and registration, the athletes will go through the initial weighing in and drawing lots formalities as stipulated in the schedule. All Sanda athletes will be required to weigh-in daily during the competition. Details regarding this will be circulated at a later time once finalized.
- Kicks to the head as well as successive/continuous punches to the head are not permitted.
- The duration of each round shall be 1 minute 30 seconds.

G. COSTUMES & EQUIPMENT

1. TAOLU:

- Competitors shall wear wushu competition costumes and use the equipment in compliance with the rules during all events.
- The costumes and equipment be brought & prepared by the competitors themselves.
- Two (2) competition bibs (20cm*15cm) for each athlete's use will be provided by the Organizing Committee to Teams upon

accreditation. All Taolu athletes must present their competition bibs to judges before entering the competition arena.

2. SANDA:

- Competitors shall wear costumes and protective gear in compliance with the "IWUF Wushu Sanda Competition Rules & Judging Method 2017" to participate in the competition.
- Each competitor is required to possess two (2) sets of competition costumes: one set in blue and one set in red.
- Each competitor is required to possess their own mouth guard, jockstrap, and instep guard.
- The gloves and protective equipment (head guard and chest protector) will be provided by the Organizing Committee.

3. CEREMONIES:

- All Teams must follow the IWUF Brand Control Guidelines for Wushu Competition Uniforms.
- All Teams must wear their official national/territorial team uniforms at the Opening and Closing Ceremonies.
- Medalists are expected to attend the Awards Ceremony in their national/territorial team uniforms; however, they are permitted to attend the ceremony wearing competition uniforms should the ceremony take place immediately after the competition.
- Athletes are expected to take off caps/hats during the ceremony.
- Athletes and officials are not allowed to take any religious symbols to or onto the awarding podium.

H. PLACING & AWARDS

1. TAOLU:

Awarding for all Taolu events will be respectively as follows:

- 1st – 8th place: If the number of competitors is 10 and above in a single event
- 1st - 3rd place: If the number of competitors is between 6 & 9 in a single event
- 1st - 2nd place: If the number of competitors is between 3 & 5 in a single event
- No placing or awards will be bestowed if the number of competitors in a single event comprises of 2 (two) or less competitors.

Awarding for all Sanda events will be respectively as follows:

- The top three place athletes within each weight category will be receive a placing and award for both boys and girls.
- Third place athletes will be placed in juxtaposition.

3. AWARDS CEREMONY

- The Awards Ceremony of Taolu will take place in each Taolu competition session.
- The Awards Ceremony of Sanda will take place in the last Sanda competition session.
- Ten minutes before the Awards Ceremony starts, the medalists will be escorted by staff to the Waiting Area to get ready for the ceremony. Medalists must wear their team official uniforms.
- The medalists are required to attend the Awards Ceremony. In case a medalist is unable to attend the ceremony for a valid reason, his/her medal and certificate may be presented to an official of the relevant delegation. Absence without a valid reason will forfeit the right to receive a medal. The medalists are not allowed to take any religious symbols to or onto the podium.
- If fewer than three (3) medalists in a single event, no Victory Ceremony will be held for that event. The team leader will go to the designated place to receive medal and certificate.

I. ENTRIES

1. Preliminary Entries

The Preliminary Entry Forms must state the exact number of competitors taking part in the events. The preliminary entry forms must reach the Organizing Committee and the IWUF Secretariat no later than 24:00 (Brunei & Beijing Time respectively) June 21st, 2024. 2. Final Entry:

All final entries must be submitted through the IWUF Online Registration System. All sections of the online entry must be completed in full, including the uploading of the various required documents. The deadline for the final entry to be completed through the online system is 24:00 (Brunei & Beijing Time) on August 15th, 2024. Each team is required to print a copy of the submitted final entry and present it upon arrival and registration in Bandar Seri Begawan, Brunei Darussalam. Late entries are subject to the approval of the IWUF and if accepted are subject to a late-entry fee of US\$100 per participant.

J. ARRIVAL & REGISTRATION

1. All participating teams are required to arrive at the designated registration booth and register with the 9th WJWC Organizing

Committee no later than 24:00 (Brunei Time) on Sep 23rd, 2024.

2. Upon arrival, all teams are required to: Submit all the required documents and items stipulated within these regulations.
3. All judges are required to arrive and register at the designated registration booth on Sep 22nd, 2024.
4. All Teams and judges are required to register with the 9th WJWC Organizing Committee at the designated Accreditation Center no later than September 23rd, 2024.
5. Accreditation Center(s) will open at 9:00 on September 22nd, 2024. Upon arrival at the Accreditation Center, the Team leader is required to complete the accreditation process with the Organizing Committee. Accreditation cards will be given to the team leader upon completion of the accreditation process. All personnel must participate in the official activities with their accreditation card during the 9th WJWC.
6. Upon arrival at the Accreditation Center, the Team leader is required to complete the following process with the Organizing Committee. Each team is required to bring the following:
 - Passport copies for each participant
 - Final Entry Form with signature and stamp
 - 3 x National flags (1m×2m);
 - National anthem (short version) on CD and USB;
 - Valid Health Certificates of all athletes and Life Accidental Injury Insurance Certificate (valid for the respective country or region);
 - Completed and signed 9th WJWC "Waiver of Liabilities" for each participant.
 - Confirmation of Taolu Athletes' Registration form with Difficulty Techniques of Operational Routine.
 - Pay the participation fee in full.

K. TECHNICAL OFFICIALS

1. Each participating Taolu Team may submit one IWUF certified Taolu judge who is holding a valid certificate at the time of competition. Each participating Sanda team may submit one IWUF certified Sanda judge who is holding a valid certificate at the time of competition. All international judges must present their valid certificates issued by IWUF upon registration. Judges must have participated in and passed the examination of the 2023 or 2024 IWUF International Judges Examination Course in order to qualify to judge at the 9th WJWC.
2. The IWUF shall select and appoint the independent Judges for officiating the competition.

L. TECHNICAL MEETING

The Technical Meeting for team managers and coaches will take place on Sep 24th, 2024 during which all matters related to the competition will be announced. Each team should send two representatives for Taolu and two representatives for Sanda to attend this meeting.

M. DRAWING – LOTS

The drawing-lots of the 9th WJWC will be conducted on Sep 24th, 2024. Each team may send two Taolu and two Sanda representatives to attend the ceremony. The delegate of Jury of Appeals will draw on behalf of the teams that are unable to send a representative to attend.

N. WEIGHING-IN

1. The initial weighing-in for Sanda athletes will take place at 07:00 (Brunei Time) on Sep 24th, 2024.

2. The weighing-in will be conducted on daily basis. The venue for weighing-in will be circulated by the Organizing Committee in due course.
3. Accreditation cards and passports must be presented at each weigh-in session. A Sanda athlete's failure to attend any required weigh-in will result in his/her disqualification from the competition.

O. FINANCIAL CONDITIONS

1. The international airfare and related travel expenses, as well as accommodation/participation fees of all participants shall be borne by the teams themselves. The accommodation/participation fees are as follows:

- **For Athletes & Team Officials:**

- Category A-** Badiyah Hotel, Higher Hotel, Star Lodge and Parkview Hotel

- Twin /Double Room: USD140.00 per person per day

- Single Room: USD165.00 per person per day

- Category B-** The Centrepoin Hotel & Mulia Hotel

- Twin/Double Room: USD160.00 per person per day

- Single Room: USD185.00 per person per day

- **For Team Judges:**

- Twin/Double room: USD170 per person per day

- Single Room: USD200.00 per person per day

- The above fees include meals, accommodation, event participation and pick-up/drop-off to and from the airport. The participating teams shall pay their participation fees in full to the organizing committee by international wire transfer with the submission of their final entries.
- It is important to note that each national/regional federation will be fully responsible for the total costs stated on

their team's final registration irrespective of whether or not all the registered participants actually arrive and participate in the championships.

2. The Organizing Committee will arrange the accommodation and transportation for participating teams from 08:00 Sep 22nd, 2024 to 12:00 Sep 30th, 2024 (Brunei Time). If any team is arriving earlier or departing later than the required date, they should inform the Organizing Committee to arrange their accommodation arrangements before Aug 21st, 2024. Participants arriving early or departing late may be subject to additional costs related thereto which shall be borne by the participants themselves.
3. The IWUF and Organizing Committee require that all participating teams lodge must be at the designated hotels arranged by the Organizing Committee.
4. **Payment Methods**
Participating teams are required to pay the relevant participation fees by international wire transfer with their final entry submission. Following the submission of a final entry, the organizing committee will contact each team and provide them with their invoice, which will state totals and bank/payment details. Teams are then required to transfer the full amount as stated on the invoice. All international wire transfer and bank fees are to be paid by the teams transferring the funds themselves. Proof of full payment should be sent to the organizing committee by email and brought along to Brasilia by the team leader. The organizing committee requires that all participation fees are to be paid in advance in order to secure accommodation as required by the official hotels. The organizing committee will be unable to guarantee a team's required accommodation without pre-payment in full. Teams are requested to be mindful of this when submitting their final registration.

P. DOPING CONTROL

Doping control will be conducted during the 9th WJWC according to the requirements of the IOC and World Anti-Doping Agency, and will follow the procedure prescribed in the IWUF Anti-Doping Rules. The number of tests will be decided by the ITA. If an athlete is found have positively doped through the doping process, he/she will be dealt with in accordance with the IWUF Anti-Doping Rules.

Q. SUPERVISORY COMMISSION

1. A 9th WJWC Supervisory Commission shall be established by the IWUF, with the right to resolve any disputes or investigate any issues that arise during the course of the 9th WJWC to ensure the smooth execution of the event.
2. The Supervisory Commission for an IWUF World Junior Championships consists of three to five (3-5) members appointed by the President of the IWUF and is responsible for overseeing Championships management and dispute mediation for the entire duration of the Championships and not beyond. Specific descriptions of responsibilities include:
 - The Commission will ensure that Championships adhere to principles of fair play, impartiality, and transparency.
 - The Commission represents the IWUF in handling disputes regarding the Championships that arise between National Federations (NFs) and/or teams and/or the LOC, and has the right to resolve such disputes. However, the Commission does not interfere with the competition proceedings or disputes arise within the competition, which are responsibility of Jury of Appeal and relevant judging panel.
 - The Commission represents the IWUF in coordinating between NFs and/or teams and/or the LOC.
 - The Commission shall report any irregularities or violations observed during the Championships to the IWUF President and

the IWUF Executive Board.

- The Commission shall monitor and demand that NFs take responsibility for their athletes' general attitude and comportment.

R: RESPONSIBILITY OF MEMBER FEDERATIONS

NFs are responsible for their officials, coaches, athletes, and observers adhering to the IWUF and to all relevant rules established by the IWUF and the Organizing Committee. NFs should ensure that their participants hold themselves to the highest standards in all their actions during the event.

1. Fundamental Principles

All NFs' Team members participating in the 9th WJWC must observe and respect the IWUF constitution, rules, regulations, and representatives. Individuals deemed to have acted against the IWUF, its principles, interests or purpose may be subject to suspension or expulsion from the event and/or cancellation of their accreditation.

2. Attitude of Athletes and Coaches

The athletes will compete under the responsibility of their NFs. NFs are fully responsible regarding the general attitude and comportment of their athletes. Coaches should respect the judging panel and all complaints must be conducted in accordance with competition procedures. Athletes and Coaches should comply with the IWUF Ethic Codes.

3. Image of Athletes

Each NF is responsible for obtaining the rights for the IWUF to use its athletes' images at the discretion of the IWUF for promotional purposes in all forms.

4. Insurance

Each NF is fully and sole responsible for insuring its athletes against injury and third-party risk (public liability) during the period of the 9th WJWC. The IWUF and the Organizing Committee are not responsible in part or in whole of the said liability.
