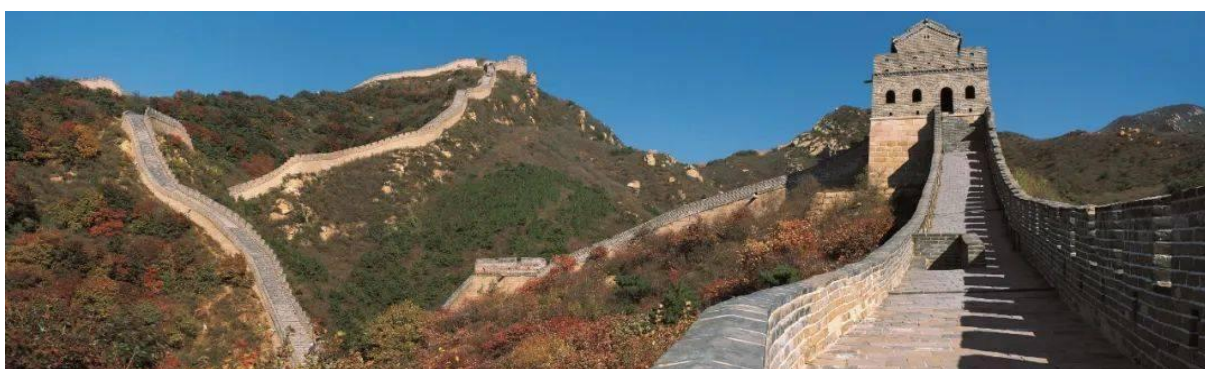

## I. GENERAL INFORMATION

### 1. INTRODUCTION

#### 1.1 China Overview

China, one of world's most ancient civilizations, has a history dating back over 5,000 years. This has led to the country having an extraordinarily rich cultural heritage. As the world's largest developing country, China has seen remarkable progress in its economic and social development. Today's China is politically and socially stable, and economically prosperous, with its people's lives getting better each day.



##### 1.1.1 Geography

China is located on the east side of Asia and the west edge of the Pacific Ocean. Covering a land area of about 9.6 million square kilometers, it features over 18,000 kilometers of continental coastline along its eastern and southern edges, and approximately 4.7 million square kilometers of inland and border seas. There are more than 7,600 islands of varying sizes in the sea area, among which the island of Taiwan, with an area of 35,798 square kilometers, is the largest.

##### 1.1.2 Climate

Given its sheer size, it is perhaps not surprising that China has a range of climates. Most of the country lies in northern temperate zone that features a mild, continental monsoon climate and four distinct seasons.

##### 1.1.3 Population, Ethnicity and Language

Population: 1,411.78 million.

Ethnicity: China is a multi-ethnic country with 56 ethnic groups in total.

Language: There are more than 80 local languages and about 30 Chinese writing systems. Mandarin



(also known as Putonghua) is the country's national language.

#### 1.1.4 Religion

Religion: China is a multi-religious country. The main religions are Buddhism, Taoism, Islam, Catholicism and Christianity. Chinese citizens enjoy freedom of religious belief.

#### 1.1.5 Others

China shares borders with 14 countries and is adjacent to eight countries by sea. The capital city is Beijing. China is comprised of provincial-level administrative divisions that can be further classified into: 4 municipalities directly under the central government, 23 provinces, 5 autonomous regions and 2 Special Administrative Regions.

Currency: The legal currency is renminbi (RMB), with yuan as the basic unit, and jiao and fen as fractions of this basic unit. One yuan is equal to 10 jiao and one jiao equal to 10 fen. Foreign currency can be freely exchanged in most hotels and banks on the Chinese mainland.

### 1.2 Tianjin Overview

Tianjin, abbreviated as “Jin” and historically referred to as Jingu or Jinmen, is one of the four municipalities directly under the Central Government of the People’s Republic of China. As a national central city and megacity, Tianjin is situated on the western coast of the Pacific Ocean, in the northeastern part of the North China Plain, at the lower reaches of the Haihe River Basin. It borders the Bohai Sea to the east, the Yanshan Mountains to the north, and Beijing to the west, with Hebei Province surrounding it on all other sides. Tianjin sits at the confluence of the five major tributaries of the Haihe River, earning it titles such as the “Downstream Terminus of Nine Rivers” and a “Strategic Junction of River and Sea”. The city experiences a warm temperate, semi-humid monsoon climate with distinct seasons. The municipality is administratively divided into 16 districts, with a total area of 11,966.45 square kilometers. As of the end of 2024, Tianjin’s permanent resident population was 13.64 million.





Tianjin rose to prominence due to its strategic position in the imperial grain transport system. On December 23, 1404 (the 21st day of the 11th lunar month in the 2nd year of the Yongle era of the Ming Dynasty), the city was officially established, making it the only ancient Chinese city with a precisely documented founding date. Over more than 600 years, Tianjin has developed a distinctive blend of Eastern and Western architectural styles and a mix of historical and modern cultural elements.

Tianjin has emerged as a pivotal national center - a city celebrated for its rich history and culture, while serving as a modern maritime hub. As northern China's premier logistics and manufacturing center, it functions as a major international transportation nexus, a national leading advanced manufacturing and R&D base, the core international shipping hub in northern China, and a pilot zone for financial innovation and operations. Strategically positioned, Tianjin serves as a primary node on the China-Mongolia-Russia Economic Corridor, a strategic pivot on the Maritime Silk Road, a critical junction along the Belt and Road Initiative, and the easternmost starting point of the Eurasian Land Bridge. Additionally, it provides vital sea access for landlocked neighboring countries and remains the largest port city in northern China, while acting as both gateway and strategic buffer for the capital region.

### 1.3 International Airport

**Tianjin Binhai International Airport** (IATA: TSN, ICAO: ZBTJ) is located in Dongli District, approximately 13 kilometers from the city center. As a 4E-class civil international civil airport, it serves as a national air logistics hub, an international scheduled flight airport, a first-class international aviation port, and a major air cargo hub in China. At present, Tianjin Binhai International Airport operates 155 flight routes, with 3,647 scheduled flights per week, connecting 127 domestic and international cities.



### 1.4 Weather

Historical average temperatures for Tianjin in March range from 9°C–15°C.

### 1.5 Electricity

The electricity standard in China is 220V (50Hz).



## 1.6 Telephone

To call China from abroad, dial +86 (country code) followed by city code, followed by the local number.

## 2. INTRODUCTION TO WORLD JUNIOR CHAMPIONSHIPS

Hosted by the International Wushu Federation (IWUF), the World Junior Wushu Championships (WJWC) is the official pinnacle junior championships of the IWUF and features its highest competitive level amongst its junior athletes. This biennial event began in 2006, and since then nine editions have been held. The 10<sup>th</sup> WJWC will be held in Tianjin, China from March 23 to 31, 2026. The Chinese Wushu Association is responsible for the organization of the 10<sup>th</sup> WJWC under the auspices of the IWUF.

## 4. VENUES



**Tianjin Gymnasium**, built in December 1994 and located on Binshui West Road in Tianjin, is a large-scale, comprehensive, and multifunctional facility hosting sports events, performances, exhibitions, and public fitness activities. The complex occupies a total area of 12.23 hectares, with a total floor space exceeding 50,000 square meters. Due to its distinctive saucer-shaped architecture, locals nickname it “The Flying Saucer” or “The Big Arena”. It has also been prominently featured in China Central Television (CCTV) broadcasts and is recognized nationwide as a symbol of Tianjin. The venue consists of four major sections: the saucer-shaped main arena, a sub arena, a training hall, and a media center, along with supporting facilities. The main arena alone covers 24,677 square meters, with a height of 35 meters, a span of 108 meters, and a steel space-frame dome with a diameter of 135 meters.

(Age for Dakar 2026 YOG is between 14 November, 2008 and 31 October, 2011)

### 8.2 Junior Age Group

**12–14** years of age (born in 2012–2014)

### 8.3 Children Age Group

**11** years of age and below (born in and after 2015)

## 9. QUALIFICATIONS

### 9.1 Membership

- Only those federations/associations which have paid their IWUF annual membership fees for 2025 will be permitted to participate in the 10<sup>th</sup> WJWC.
- New IWUF member federations may be invited to take part in the 10<sup>th</sup> WJWC after their membership



applications have been accepted by the IWUF.

Hereinafter the IWUF member federation is referred to as "NF".

## 9.2 Athlete Eligibility

- Athletes must be citizens of the country/territory that they are representing.
- Athletes who have dual citizenship can only represent one country/territory in the 10<sup>th</sup> WJWC.

## 10. PARTICIPATION METHODS

### 10.1 Quota

#### 10.1.1 Quota for NF

Each NF can enter at most **1 team**. Each team can be composed of both **taolu** and **sanda** members.

Each NF can enter a maximum of **35 members** with up to 19 members for taolu team and 16 members for sanda team.

#### 10.1.2 Quota for Taolu Team

Each taolu team shall be composed of a maximum of **19 members**.

- **Athlete**

Each team may, at most, enter **14 athletes** including:

- **Youth Athletes:** 6 athletes (a maximum of 3 boys and 3 girls)
- **Junior Athletes:** 4 athletes (a maximum of 2 boys and 2 girls)
- **Children's Athletes:** 4 athletes (a maximum of 2 boys and 2 girls)

- **Team Official**

Each team may, at most, enter **4 team officials** including:

- 1 team leader
- 2 coaches
- 1 doctor

- **Team Judge**

Each team may, at most, enter **1 taolu team judge**.



- **Observer**

Extra team delegate(s) exceeding the quota shall be registered as observer(s).

### 10.1.3 Quota for Sanda Team

Each sanda team shall be composed of a maximum of **16 members**.

- **Athlete**

Each team may, at most, enter **11 athletes** including:

- **Youth Athletes:** 8 athletes (a maximum of 5 boys and 3 girls)
- **Junior Athletes:** 3 athletes (a maximum of 3 boys)

- **Team Official**

Each team may, at most, enter **4 team officials** including:

- 1 team leader
- 2 coaches
- 1 doctor

- **Team Judge**

Each team may, at most, enter **1 sanda team judge**.

- **Observer**

Extra team delegate(s) exceeding the quota shall be registered as observer(s).

## 10.2 Participation Events

### 10.2.1 Taolu Competition

- **Youth Athletes**

Each team may enter at most **1 Men's Duilian** and **1 Women's Duilian** events in Youth group. Each Youth athlete may enter at most **4 competition events** including:

- 1 bare-hand routine
- 1 short weapon routine
- 1 long weapon routine
- 1 optional Duilian routine



**NOTE:** Athletes can enter **both Taijijian and Taijishan routines** in weapons routines.

- **Junior Athletes**

Each team may enter at most **1 Men's Duilian** and **1 Women's Duilian** events in Junior group. Each Junior athlete may enter at most **4 competition events** including:

- 1 bare-hand routine
- 1 short weapon routine
- 1 long weapon routine
- 1 optional Duilian routine

- **Children's Athletes**

Each Children's athlete may enter at most **3 competition events** including:

- 1 bare-hand routine
- 1 short weapon routine
- 1 long weapon routine

### 10.2.2 Sanda Competition

- **Youth Athletes**

- Each team may enter at most **1 Youth athlete per weight category**.
- Each Youth athlete may enter only **1 weight category**.

- **Junior Athletes**

- Each team may enter at most **1 Junior athlete per weight category**.
- Each Junior athlete may enter only **1 weight category**.

### 10.3 Relevant Documents

Upon arrival at the Accreditation Desk, team leaders must present the following documents:

- Completed and signed **Waiver of Liabilities** (Annex 1) of all participants, which must be signed by his/her parent or legal guardian for the participant who is under 18 years of age.
- **Medical Certificates** (Annex 2) of all athletes issued by a qualified medical doctor from a check-up performed within a period of **15 days** prior to the date of registration at the competition.
- **Life Accidental Injury Insurance Certificates** of all athletes.

## 11. COMPETITION RULES



Unless otherwise stated within these regulations, the competition will be conducted in accordance with:

- IWUF Wushu Taolu Competition Rules and Judging Methods (2024).
- IWUF Wushu Sanda Competition Rules and Judging Methods (2024).

Hereinafter the IWUF Wushu Taolu Competition Rules and Judging Methods (2024), and the IWUF Wushu Sanda Competition Rules and Judging Methods (2024) are referred to as “rules”.

The rules may be interpreted solely at the discretion of the IWUF. In the event of language discrepancies in the rules, the English version shall prevail.

## 12. COMPETITION METHODS

### 12.1 Taolu Competition Methods

Within taolu competition, the “Events without Degree of Difficulty Scoring Methods and Standards” will be implemented.

#### 12.1.1 Preliminaries and Finals

- **Preliminaries**
  - In the case when the number of participants in an event exceeds **50 athletes**, the athletes will be divided randomly and evenly into several groups by the computer for preliminaries.
  - The athletes' start order of each group in preliminaries is determined by a drawing of lots.
- **Finals**
  - The finals consist of **12 athletes**. Equal numbers of top finishers from each group will qualify for the finals.
  - The athletes' start order in finals is determined by a drawing of lots that will be held **1 day prior to the date of finals**.

#### 12.1.2 Routine Time Limits

- Changquan, Nanquan, Jianshu, Daoshu, Qiangshu, Gunshu, Nandao and Nangun routines: Not less than 1 minute 10 seconds in total duration
- Taijiquan (36), Taijijian (39) and Taijishan (40) routines: From 3 to 4 minutes in total duration
- Taijiquan (42) routines: From 5 to 6 minutes in total duration
- Taijijian (42) routines: From 4 to 5 minutes in total duration
- Optional Duilian routines: From 50 seconds to 1 minutes in total duration
- Elementary routines: No requirements for the routine performance duration



### 12.1.3 Accompanying Music

- Accompanying music is required for:
  - 1<sup>st</sup> Set of International Wushu Competition Routines: Taijiquan (42), Taijijian(42)
  - 3<sup>rd</sup> Set of International Wushu Competition Routines: Taijiquan (36), Taijijian (39), Taijishan (40)
- Each NF must upload the accompanying music through the IWUF Online Registration System with their final entry submission. **NFs shall be responsible for the music copyright used.**
- Accompanying music with vocals and/or lyrics is not permitted.

### 12.1.4 Roll-Call

- Athletes shall report to the designated Roll-call Area at:
  - 30 minutes prior to the start of the event (first roll-call)
  - 20 minutes prior to the start of the event (second roll-call)
  - 10 minutes prior to the start of the event (final roll-call)
- Failure to be present for roll-call will result in forfeit.

## 12.2 Sanda Competition Methods

### 12.2.1 Competition Format

- The competition will utilize the single-knockout system.
- If the number of athletes in a given weight category is 3, a single round-robin competition system will be adopted.
- The duration of each round shall be 1 minute 30 seconds with a 1-minute rest in between.

### 12.2.2 Permitted and Prohibited Techniques

- **Youth Competition**

Athletes may strike the opponent's head with kicks and continuous punches.

- **Junior Competition**

Athletes may continuously punch the opponent's head, but kicking the opponent's head is strictly prohibited.

### 12.2.3 Daily Weigh-In



- Following arrival and accreditation, athletes will undergo an initial weigh-in and drawing of lots as stipulated in the schedule.
- Athletes competing on a specific day of competition are required to weigh-in at the specific time and place prior to the start of the day's event.

## 13. COSTUMES AND EQUIPMENT

### 13.1 Compliance Requirement of Marketing and Advertising

All teams must follow the IWUF Brand Control Guidelines for Wushu Competition Uniforms (excerpt) (Annex 3).

### 13.2 Uniforms, Weaponry and Equipment Requirements for Competition

#### 13.2.1 Taolu Competition

Athletes shall wear wushu competition costumes and use the competition weaponry in compliance with the rules during all events.

- All athletes must provide their own uniforms and weaponry.
- 2 competition bibs (20cm\*15cm) for each athlete's use will be provided by the LOC to the teams upon accreditation. The athlete should show his/her competition bib to the Head Judge before he/she enters the competition mat.

#### 13.2.2 Sanda Competition

Athletes shall wear costumes and protective gear in compliance with the rules to participate in the competition.

- Each athlete must provide 2 sets of competition uniforms: 1 set in red and 1 set in blue.
- Each athlete must provide their own gum guard, groin cup, hand wraps, instep guard and **shin guard (applicable for junior competition)**. Otherwise, participation in the competition will not be permitted.
- Gloves, headgear and chest protector manufactured by the IWUF's certified supplier(s) will be provided by the LOC.

### 13.3 Clothing Requirements for Opening and Closing Ceremonies

All teams must wear their official national/territorial team uniforms at the Opening and Closing Ceremonies.

### 13.4 Clothing Requirements for Awards Ceremony



Medalists are expected to attend the Awards Ceremony in their national/territorial team uniforms.

### 13.5 Compliance Check at Roll-Call Area

Uniforms and weapons checks will be conducted at the Roll-call Area in accordance with stated regulations and requirements. Uniforms and weapons checks are conducted by the Chief Registrar and the Roll-call Officials as stipulated in the rules. Non-compliance may be subject to disqualification from the competition.

## 14. PLACING AND AWARDS

### 14.1 Taolu Competition

- **1<sup>st</sup> place:** Gold medal and Certificate
- **2<sup>nd</sup> place:** Silver medal and Certificate
- **3<sup>rd</sup> place:** Bronze medal and Certificate
- **4<sup>th</sup>–8<sup>th</sup> place:** Certificate

***Awarding for taolu events will be respectively as follows:***

- **1<sup>st</sup>–8<sup>th</sup> place:** If the actual number of participants is 10 and above in a single event.
- **1<sup>st</sup>–5<sup>th</sup> place:** If the actual number of participants is between 6 and 9 in a single event.
- **1<sup>st</sup>–2<sup>nd</sup> place:** If the actual number of participants is between 3 and 5 in a single event.

***No awards will be bestowed if the actual number of participants is 2 or less athletes in a single event.***

### 14.2 Sanda Competition

- **1<sup>st</sup> place:** Gold medal and Certificate
- **2<sup>nd</sup> place:** Silver medal and Certificate
- **3<sup>rd</sup> place (juxtaposition):** Bronze medal and Certificate

### 14.3 Participation Certificate

All accredited personnel, including team leaders, coaches, doctors, observers and athletes will receive a 10<sup>th</sup> WJWC participation certificate.

Team leaders are required to collect the participation certificates, as well as the award certificates of athletes placing 4<sup>th</sup>–8<sup>th</sup> (if applicable), at the Results and Certificates Office.

## 15. AWARDS CEREMONY



## 15.1 Medalists

Medalists must:

- Attend the Awards Ceremony to receive their medals **in person**.
- Be escorted by staff to the Waiting Area **10 minutes** before the ceremony to prepare accordingly.
- Not bring any national/territorial, cultural or religious symbols onto the podium.
- Remove caps, hats, and sunglasses throughout the Awards Ceremony.
- Face the flags during they are being raised.

## 15.2 Athletes and Team Officials

Athletes and team officials are required to remain in the designated area.

## 15.3 Special Cases

### 15.3.1 Medalist Absence

- In case a medalist is unable to attend the ceremony for a valid reason, his/her medal and certificate may be presented to the appointed official of the team.
- Absence without a valid reason will result in forfeiture of the right to receive a medal.

### 15.3.2 Insufficient Participants

***If there are fewer than 3 medalists in a single event, no Award Ceremony will be held for that event.*** The team leader will receive the medals and certificates at the Results and Certificates Office.

## 16. ENTRIES

### 16.1 Preliminary Entry

Preliminary entry must be submitted through ***the IWUF Online Registration System***.

Online preliminary entry will open from ***November 23, 2025***, and close at ***23:59*** on ***December 22, 2025***.



All teams must state the number of athletes and team officials as accurately as possible taking part in the events so that the LOC may reserve the hotels and prepare the organization of the event accordingly. There is no guarantee for hotel rooms reservation for teams failed to submit their preliminary entry before the required deadline.

All teams are required to complete their online preliminary entry before the deadline to access the final entry system.

## 16.2 Final Entry

Final entry must be submitted through **the IWUF Online Registration System**.

All sections of the online entry must be completed in full, including the uploading of the following documents:

- Photos of the participants (white background, head filling 70-80% of the photo, at least 480 pixels in width and 600 pixels in height)
- Passports of the participants (must be valid for at least **6 months** following their final day of travel)

Online final entry will open from **December 23, 2025**, and close at **23:59** on **February 7, 2026**.

All payments due to the LOC must be paid in full for registration to be considered as completed.

Each team is required to print a copy of the submitted entry and present it to the LOC upon registration.

## 16.3 Late Entry and Changes Policy

After the final entry deadline, teams with requests for the late entries or changes must submit a written document for approval and shall pay corresponding fees before the late entry and changes deadline, otherwise request will be denied.

Late entry and changes will open from **February 8, 2026**, and close at **23:59** on **March 7, 2026**.

Any request to change the entry (including the late entry) will be handled as follows:

- The late entry is subject to the approval of the IWUF and, if accepted, it will incur a late-entry fee of **USD 100** per participant.
- Replacing a participant is subject to approval by the IWUF and, if accepted, it will incur a replacement fee of **USD 100** per participant.
- If changes are required due to incorrect or missing registration information, those changes are subject to approval by the IWUF and, if accepted, it will incur a fee of **USD 50** per change.

## 17. ARRIVALS AND ACCREDITATION

### 17.1 Arrivals

The following accredited personnel are required to register with the LOC at the LOC-designated hotels no later than:

- **Team judges: 23:59** on **March 23, 2026**
- **Athletes and team officials: 23:59** on **March 24, 2026**

### 17.2 Accreditation

Accreditation Desks will open at **09:00** on **March 23, 2026**.

Upon arrival at the Accreditation Desk, team leaders are required to complete the following process:

1	Present each team members' passports
2	Submit Final Entry Form with signature and stamp and confirm the registration information
3	Submit 3 national flags (size: 1m*2m)
4	Submit national anthem (short version) in MP3 format on a CD or USB flash drive
5	Submit signed Waiver of Liabilities of all participants (Annex 1)

6	Submit valid Medical Certificates (Sample) of all athletes (Annex 2)
7	Submit valid Life Accidental Injury Insurance Certificates of all athletes
8	Pay the relevant participation fees in full (if applicable)
9	Pay the relevant penalty fees in full (if applicable)
10	Submit a bank receipt of payment (either in paper or electronic documents)
11	Sign and confirm all the above items are completed

Accreditation cards will be given to the team leader upon completion of the accreditation process. All personnel must participate in the official activities with their accreditation cards during the 10<sup>th</sup> WJWC.

The competition and training schedules will be distributed after accreditation has concluded.

## 18. WEIGH-IN

The first official weigh-in for all athletes will take place at **06:30** on **March 25, 2026**. Furthermore, the weigh-in will be conducted on daily basis at **06:30**, athletes must attend a weigh-in on each day they participate in competition (specific places for each weigh-in will be announced accordingly).

**Accreditation cards and passports** must be presented at each weigh-in session. A sanda athlete's failure to attend any required weigh-in will result in his/her disqualification from the competition.

## 19. TECHNICAL MEETING

The technical meeting for team managers and coaches will take place at **10:00** on **March 25, 2026**. Each team should send 1–3 representative(s) to attend the meeting. The place of the technical meeting will be announced in due course.

The technical meeting content will be presented as follows:

- IWUF Event Guidelines (IWUF representatives)
- Event Logistics Information (LOC representatives)
- Event Technical Details (Chair of Jury of Appeals and Chief Referee)
- Other Matters

## 20. DRAWING OF LOTS

After the technical meeting, the drawing of lots will be conducted by the scheduler-recorder group supervised by the Jury of Appeals and the Chief Referee on **March 25, 2026**.



The drawing of lots for taolu and sanda disciplines will be held simultaneously in two separate rooms. Each team should send 1–2 representative(s) for each discipline to attend the sessions.

The Jury of Appeals will draw on behalf of the teams that are unable to send a representative to attend.

## 21. TECHNICAL OFFICIALS

### 21.1 International Technical Officials (ITOs)

- Each team may send at most **1 taolu team judge** and **1 sanda team judge** to officiate at the 10<sup>th</sup> WJWC subject to approval of the IWUF.
- The IWUF will select and appoint the independent judges and the Jury of Appeals at its discretion to serve at the 10<sup>th</sup> WJWC.
- All team judges and independent judges of the 10<sup>th</sup> WJWC must hold their valid IWUF Judge's License at the time of the competition.

#### 21.1.1 Registration

- The information for the team judges must be submitted at the time of their team registration.
- The Jury of Appeals and all independent judges appointed by the IWUF shall submit their registration information through **the IWUF Online Registration System**.
- All team judges and independent judges of the 10<sup>th</sup> WJWC must input their valid IWUF Judge's License numbers through the online registration system.

#### 21.1.2 Uniforms

All ITOs shall prepare their own black jackets, white shirts, black slacks, and black leather shoes, as well as bring the IWUF ties/scarfs.

#### 21.1.3 Judges' Refresher Course

- All 10<sup>th</sup> WJWC judges are required to participate in the judges' refresher course.
- Absence without a valid reason will forfeit the right to officiate at the 10<sup>th</sup> WJWC.

### 21.2 National Technical Officials (NTOs)

All NTOs serving at the 10<sup>th</sup> WJWC will be nominated by the LOC.

## 22. SUPERVISORY COMMISSION

The 10<sup>th</sup> WJWC Supervisory Commission shall be established by the IWUF, with the purpose of and the right to resolve any disputes or investigate any issues that arise during the course of this competition to ensure the



smooth execution of the event.

The Supervisory Commission for an IWUF competition consists of 3–5 members appointed by the President of the IWUF and is responsible for overseeing the competition management and dispute mediation for the entire duration of this competition and not beyond. Specific descriptions of responsibilities include:

- The Commission will ensure that competitions adhere to principles of fair play, impartiality, and transparency.
- The Commission represents the IWUF in handling disputes regarding the competitions that arise between the NFs and/or teams and/or LOC, and has the right to resolve such disputes. However, the Commission does not directly interfere with the competition proceedings or disputes arise within the competition, which are responsibility of the Jury of Appeals and the relevant judging panel.
- The Commission represents the IWUF in coordinating between the NFs and/or teams and/or LOC.
- The Commission shall report any irregularities or violations observed during the competitions to the IWUF President and the IWUF Executive Board.
- The Commission shall monitor and demand that NFs take responsibility for their athletes' general attitude and comporment.



### III. TEAM INFORMATION

#### 23. ACCOMMODATION

##### 23.1 Hotel Reservation

All accredited personnel are required to stay at the LOC-designated hotels.

- **Check-in Time:** After **15:00**
- **Check-out Time:** Before **14:00**

##### 23.1.1 Non-Compliance Policy

Teams unable to stay at the LOC-designated hotels due to special reasons shall pay a participation fee of **USD 200** per person. In this case:

- Teams are fully responsible for their own accommodation, meals, and transportation.
- LOC shall not be held liable for any consequences arising therefrom.

##### 23.1.2 Reservation Principles

- Hotel reservations are available on a **first-come, first-served** basis.
- Early reservations are **strongly recommended** due to limited availability.

##### 23.1.3 Meal Arrangements

The LOC will provide meals for all accredited personnel:

- From the evening of their arrival date to the midday on their departure date
- 3 meals daily (breakfast, lunch, and dinner)

##### 23.1.4 Early Arrival and Late Departure Requirements

Participants wishing to arrive or depart outside the scheduled dates must:

- Submit their intended arrival and departure dates during the final registration process.
- Confirm accommodation bookings accordingly, with daily rates applicable.

**NOTE:** Teams wishing to check in before **15:00** on **March 24** must book their accommodation starting from **March 23**.

##### 23.2 Room Assignment Rules

### 23.2.1 Teams with Odd Number of Delegates

Teams with an odd number of delegates (including athletes, team officials and observers) when having reserved double rooms, the LOC will assign the extra delegate to share a double room with a member from another team, if the individual chooses not to pay for a single room.

### 23.2.2 Team Judges

Team judges reserving double rooms will be paired with other team judges by the LOC.

## 24. TRANSPORTATION

### 24.1 Transport Services for Arrivals and Departures

Transport services between Tianjin Haibin International Airport, Tianjin South Railway Station, Tianjin West Railway Station, and the official hotels will be provided by the LOC for all accredited personnel on their arrival and departure dates.

### 24.2 Shuttle Services

## 25. FINANCIAL CONDITIONS

### 25.1 Teams

- Any international or domestic airfare and related travel expenses, as well as the participation fees of all participants shall be borne by themselves.
- The participation fees include accommodation, meals, airport pickup and drop-off, local transportation, entry (excluding the late entry and changes fees) and certificate, etc.



### 25.2 Technical Officials

- The international airfare, accommodation and meals shall be provided for the appointed independent judges and the Jury of Appeals by the LOC.
- The expenses above for the team judges shall be borne by their teams themselves.

### 25.3 Additional Costs

Participants arriving early or departing late may be subject to additional costs related thereto which shall be borne by the participants themselves.

### 25.4 Payment Methods

- All teams are required to complete full payment in advance to the LOC by **23:59** on **February 7, 2026** through international wire transfer. Until complete payment is received, hotel rooms will not be reserved, and accreditation will not be issued.
- Teams that are unable to pay through international remittance due to government policies and restrictions should communicate with the LOC in advance to make arrangements, otherwise accreditation will not be issued.
- All international wire transfer and bank fees are to be paid by the teams transferring the funds themselves.
- Proof of full payment should be sent to the LOC by email and brought along to the LOC by the team leader. The LOC requires that all participation fees are to be paid in advance in order to secure accommodation as required by the official hotels. ## 26. DOPING CONTROL AND EDUCATION

### 26.1 DOPING CONTROL

Doping control will be conducted during the 10th WJWC according to the requirements of the International Olympic Committee (IOC) and the World Anti-Doping Agency (WADA), and will follow the procedure prescribed in the IWUF Anti-Doping Rules. The number of tests will be decided by the International Testing Agency (ITA). If an athlete is found have positively doped through the doping process, he/she will be dealt with in accordance with the IWUF Anti-Doping Rules.

### 26.2 ANTI-DOPING EDUCATION

WADA/ITA certified education courses are **mandatory** to participate in the 10th WJWC for athletes, at least one of the medical personnel and the team coach. To ensure your successful accreditation and participation in the 10<sup>th</sup> WJWC, please carefully comply with the mandatory anti-doping requirements. More detailed information of anti-doping education course will be released shortly.

## 27. RESPONSIBILITY OF MEMBER FEDERATIONS

The IWUF member federations (NFs) are responsible for their officials, coaches, athletes, doctors, team judges and observers adhering to the IWUF and to all relevant rules established by the IWUF and the LOC. NFs should ensure that their participants hold themselves to the highest standards in all their actions during the event.

### 27.1 Fundamental Principles

All NFs' members participating in the 10<sup>th</sup> WJWC must observe and respect the IWUF constitution, rules, regulations, and representatives. Individuals deemed to have acted against the IWUF, its principles, interests or purpose may be subject to suspension or expulsion from the event and/or cancellation of



their accreditation.

## 27.2 Attitude of Athletes and Coaches

The athletes will compete under the responsibility of their NFs. The NFs are fully responsible regarding the general attitude and comportment of their athletes. Coaches should respect the judging panel and all complaints must be conducted in accordance with competition procedures. Athletes and coaches should comply with the IWUF Code of Ethics. Any act against the IWUF judging panel may be subject to suspension or expulsion from the event and/or cancellation of their accreditation and/or competition results.

## 27.3 Image of Athletes

Each NF is responsible for obtaining the rights for the IWUF to use its athletes' images at the discretion of the IWUF for promotional purposes in all forms.

## 28. INSURANCE

Each NF is fully and sole responsible for insuring its athletes against injury and third-party risk (public liability) during the period of the 10<sup>th</sup> WJWC. The IWUF and the LOC are not responsible in part or in whole of the said liability.

## 29. PASSPORT AND VISA REQUIREMENTS

All participants must hold a valid passport and should allow plenty of time for visa application and processing.

To ensure as few complications during visa application and travel as possible, it is suggested that all participants' passports are valid for at least 6 months following their final day of travel.

Teams that require visa invitation letters should state their requests in the Entry Form from **November 23, 2025**.

If you need any assistance on visa issues, please contact the LOC via email.

**NOTE:** We **strongly recommend** teams that need to apply for visas do so **as early as possible**.

I understand it is my personal obligation to obtain my own medical coverage. I am fully and solely responsible for adequately insuring myself against injury and third-party risk (public liability), with such insurance to cover the period before, during and



after the event. The IWUF and the Organizing Committee including all associates are not responsible in part or in whole for any damages or medical or hospital expenses incurred as a result of participation in the 10<sup>th</sup> World Junior Wushu Championships.

I agree to abide by and follow the Rules established by the IWUF and the Organizing Committee and follow all received instructions. I acknowledge and agree that it is my personal responsibility to be informed about all afore-mentioned Rules and instructions. I agree that I will conduct myself in a professional and courteous manner at all times and to be subject to penalties and sanctions for violations related thereto, pursuant to the IWUF Constitution and the IWUF Ethics Code as updated from time to time and other Rules established by the IWUF and the Organizing Committee. I understand that any dispute must be resolved in accordance with the IWUF Constitution and any further applicable IWUF Rules. I agree that my performance, attendance, and participation at the 10<sup>th</sup> World Junior Wushu Championships may be photographed, filmed or otherwise recorded or released or telecast live. I consent to allow the IWUF and the Organizing Committee use of my name, likeness, address, voices, poses, pictures, videos, live or non-live coverage and biographical and biological data concerning full or parts, in any form or language ("Identity, Voice and Image Data"), with or without other material, throughout the world, without limitation, for television, radio, video, theatrical medium picture, or any other medium and any other purpose by the IWUF or the Organizing Committee through any devices now known or hereafter devised and I do hereby waive any compensation in regard thereof as well as any future rights to the aforementioned. ## **International Wushu Federation (IWUF) Brand Control Guidelines for Wushu Competition Uniforms (excerpt)**

### **1. PURPOSE**

To ensure sponsor and manufacture rights by establishing a standard for brand placement on uniforms and other clothing items used during IWUF wushu competition.

### **2. STANDARDS AND GUIDELINES**

Uniforms of athletes, coaches and team officials

### **3. GENERAL REQUIREMENTS**

The manufacturer logo may appear once on each piece of clothing, with an area of up to 20 cm<sup>2</sup>. Note that only the quantity and size of logos appearing on uniforms will be assessed during the competition, and logos will not be reviewed for accuracy or adherence to brand standards.

The manufacturer logo may appear once on each accessory item (paired accessories are considered as two items), with an area of up to 6 cm<sup>2</sup>.

A manufacturer logo may appear once on each shoe or foot item (paired shoes or foot items are considered as two items), with an area of up to 6 cm<sup>2</sup>.

A national/regional Olympic Committee flag, a national/regional wushu federation flag/logo may each appear once where specified, with an area of up to 20 cm<sup>2</sup> each.

#### **3.1 WUSHU TAOLU COMPETITION UNIFORM REQUIREMENTS**

- ***Top/Jacket***

- ***Front***

- No advertisements or logos may appear on the collar.

- A flag may appear on the left chest area, with an area of up to 20 cm<sup>2</sup>.

- The manufacturer logo may appear on the right chest area, with an area of up to 20 cm<sup>2</sup>.

- No advertisements may appear in other areas.

- ***Back***

- Sponsor or other logos may be displayed in other areas. The total number of sponsor or other logos



may not exceed three, with a maximum area of 20 cm<sup>2</sup> each.

● **Pants/Trousers**

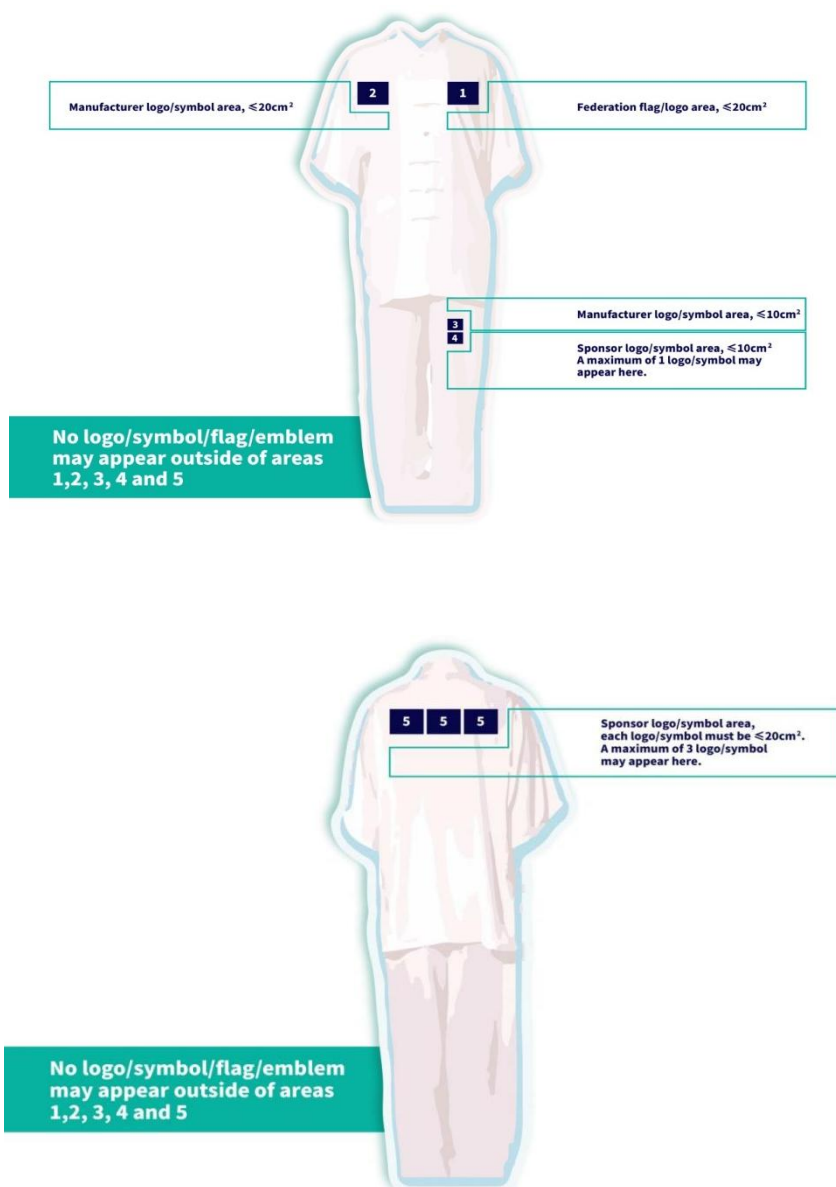

The manufacturer logo may be arranged on the top, with an area of up to 10 cm<sup>2</sup>.

No logo, flag, or other emblem may appear

Sponsor or other logos may be displayed in other areas but may not appear within 5 cm of the flag or manufacturer logo. The total number of sponsor or other logos may not exceed one, with a maximum area of 20 cm<sup>2</sup>.

### ○ **Back**

Sponsor or other logos may be displayed in back areas. The total number of sponsor or other logos may not exceed three, with a maximum area of 20 cm<sup>2</sup>.

## ● **Shorts**

### ○ **Left leg**

The manufacturer logo may be arranged on the top, with an area of up to 10 cm<sup>2</sup>.

Sponsor logos may appear below the manufacturer's logo but may not appear within 5 cm of the manufacturer's logo. The total number of sponsor or other logos may not exceed one, with an area of up to 10 cm<sup>2</sup>.

### ○ **Right leg**

No logo, flag, or other emblem may appear.
